JUDGMENT:

On April 19, 2023, the Executive Director of the Louisiana Motor Vehicle Commission (the "Commission") denied the issuance of a Louisiana motor vehicle sales finance license to Pelican Motors and Finance LLC of 8651 West Judge Perez Drive, Chalmette, Louisiana 70043 ("Pelican Motors").

Pelican Motors sought a hearing before the Commissioners for reconsideration and reversal of the Executive Director's denial of the issuance of a motor vehicle sales finance license.

On Monday, May 8, 2023, The Commissioners convened a hearing on Pelican's request for reconsideration and reversal of the Executive Director's decision to deny.

R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that Executive Director Lessie House's denial of issuance of a Louisiana Motor Sales Finance license to Pelican Motors And Finance LLC be and is hereby affirmed.


