With regard to Hearing #2012-012, Weldbilt Commercial Boats, the Executive Director advised the Commission Members the matter had been continued until May 14 12, 2012.

The Executive Director advised the Commission Members a bond waiver request had been received on January 25, 2012 from Frank T. Cholewicki, Global Vice President of Finance of JLG Industries, Inc. along with copies of its financial statement; its parent company, Oshkosh Corporation's Annual Reports; and Oshkosh's Limited Guaranty to JLG Industries:

"JLG Industries, Inc. is a wholly-owned subsidiary of Oshkosh Corporation. Attached please find the most recent Oshkosh Corporation Annual Report. Due to the financial strength of Oshkosh Corporation, we hereby request that the requirement for a surety bond be waived.

Thank you very much for your consideration."

A brief discussion ensued after the Commission Members reviewed JLG Industries' financial statements. Commissioner Hocevar made a motion to waive the bond requirement of LSA-R.S. 32:1254D(6)(a) for JLG Industries, Inc. Commissioner Bent seconded this motion and it was unanimously approved.

The Executive Director advised the Commission Members that the Commission staff received a telephone call from John H. Thomas, Jr., attorney for Deep South Fire Trucks, Inc. requested to be placed on agenda for a request of the one-million-dollar bond waiver. On February 17, 2012, the Commission received a copy of financial statements. At this time, the Chairman opened the floor for Mr. Thomas to address the Commission Members regarding Deep South Fire Trucks' financial updates. Mr. Thomas responded to the questions posed by the Commission Members regarding Deep South Fire Trucks' operations and its financials. After a brief discussion, Chairman Brandt gave Mr. Thomas thirty days to obtain a guarantee note from the owner of Deep South Fire Trucks for the company's liability. Commission LeBlanc made a motion to give the Chairman the authority to make a determination whether to grant the waiver of the bond after reviewing the requested documents, pursuant to LSA-R.S. 32:1254D(6)(a) for Deep South Fire Trucks, Inc. Commissioner Hocevar seconded this motion.

The Executive Director advised the Commission Members a bond waiver request had been received on February 13, 2012 from Chasity King of Forest River, Inc. along with a copy of financial statements:

"Forest River, Inc. Is requesting a waiver on the million dollar business bond that is required by Louisiana on new Converter Licenses for the Federal Coach and Rockport Divisions.

There are several divisions already licensed with Louisiana Motor Vehicle Division. Forest River, Inc. Has the combined capability to manufacture 4000 units per week in various plants. Replacement parts are available for current production as well as past production. The stability of the company is shown by the sixteen years of being in business. I have also attached financial reports to verify funds.

If there are any question please feel free to contact me."

After reviewing Forest River's financial statements a brief discussion ensued. Commissioner Hocevar made a motion to waive the bond requirement of LSA-R.S. 32:1254D(6)(a) for Forest River's Federal Coach and Rockport Divisions. Commissioner Corley seconded this motion and it was unanimously approved.

New Orleans Audi will display 8 cars on Thursday, May 24, 2012 for the Royal Street Stroll on Royal Street. The same 8 vehicles will be displayed for the NOWFE Grand Tasting on Friday, May 25, 2012 and Saturday, May 26, 2012 in the New Orleans Convention Center. This is within our primary market area."




