- 2. Bayou Outdoor Super Center did not at that time possess a Louisiana Motor Vehicle issued dealer's license.

#### CONCLUSION OF LAW:

Based upon above Findings of Fact, the Commission concludes that Southfork Custom Boat Mfg. Inc.:

 Violated LA-R.S. 32:1270.1 (1)(f) when Southfork Custom Boat Mfg. Inc. DBA Southfork shipped or sold twelve (12) boats to Bayou Outdoor Supercenter prior to Bayou Outdoor Supercenter having been granted a license by the Louisiana Motor Vehicle Commission to sell said marine products; and

Considering the forgoing finding of facts and conclusion of law, and pursuant to the authority vested in the Commission as set forth in La. R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that Southfork Custom Boat Mfg. Inc. DBA Southfork be and is hereby assessed a fine in the amount of TWO THOUSAND FIVE HUNDRED (\$2,500.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, and DECREED that Southfork Custom Boat Mfg. Inc. DBA Southfork pay the cost of the full board hearing in this matter to the Commission in the amount of ONE THOUSAND EIGHT HUNDRED AND TWENTY-SIX AND 02/100 (\$1,826.02) DOLLARS, in addition to the fine as sessed herein.
