After a brief discussion, Commissioner Lane made a motion to approve the above-listed dealerships' request to participate in Cleco's EV Ride and Drive event as presented, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in each dealer's email remaining constant. Commissioner Stephen Guidry seconded this motion and it was unanimously approved.

At this time, Counselor LaPeyronnie reported to the Commission Members regarding the on-going litigation regarding Skyrunner, LLC (United States District Court, Western District of Louisiana, Shreveport Division).

A brief discussion ensued.

Executive Director Casey stated Counselor LaPeyronnie's two-year legal contract would also expire on January 11, 2024 and requested his renewal contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$480,000.00 for the period commencing January 12, 2024 and ending on January 11, 2026." The Executive Director continued by stating that Counselor Reggie's two-year legal contract would expire on January 31, 2024 and requested his renewal contracts be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$480,000.00 for the period commencing February 1, 2024 and ending on January 31, 2026." In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.

CONSENT JUDGMENT

IT IS AGREED, ADJUDGED, AND DECREED that Insight Material Handling, LLC, in complete satisfaction and settlement of the Alleged Violations, pay to the Louisiana Motor Vehicle Commission in the amount of NINETY-EIGHT THOUSAND AND THREE HUNDRED (\$98,300.00) DOLLARS. The Commission agrees, as part of this settlement, that this consent judgment is prospective so any other alleged violation by Insight Material Handling, LLC of the same provision that pre-dates the Alleged Violations addressed in this consent judgment will not be pursued as a violation.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that SIXTY THOUSAND (\$60,000.00) DOLLARS of the aforementioned \$98,300.00 be suspended conditioned upon Insight Material Handling, LLC obtaining a lessor license within thirty (30) days of the pre-hearing conference which was held on September 11, 2023, which deadline was extended by the Louisiana Motor Vehicle Commission and Insight Material Handling, LLC has obtained such license within such extended deadline.

IT IS FURTHER AGREED, ADJUDGED, AND DECREED that Insight Material Handling, LLC pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of FOUR HUNDRED (\$400.00) DOLLARS.


