JUDGMENT:

On Monday, November 18, 2024, a hearing on the merits of this cause was had before the Commissioners of the Louisiana Motor Vehicle Commission (the "Commission") and a determination of the Findings of Fact, Conclusions of Law, and Ruling was made by the Commission in an open hearing.

And after hearing the testimony adduced at trial, the receipt of the documentary evidence admitted into the record, and for reasons orally assigned, the Commission makes the following finding of fact and conclusion of law:

FINDING OF FACT:

Cortes Campers, LLC DBA Cortes Campers engaged in the business of a recreational product manufacturer in the state of Louisiana from January 1, 2024 through and including June 3, 2024 without being in possession of a manufacturer's license issued by the Louisiana Motor Vehicle Commission.

CONCLUSION OF LAW:

By engaging in the business of a recreational product manufacturer in the state of Louisiana from January 1, 2024 through and including June 3, 2024 without being in possession of a manufacturer's license issued by the Louisiana Motor Vehicle Commission, Cortes Campers, LLC DBA Cortes Campers violated La. R.S. 32:1254.A.(1).

Considering the forgoing finding of fact and conclusion of law, and pursuant to the authority vested in the Commission as set forth in La. R.S. 32:1251, et seq.

IT IS ORDERED, ADJUDGED AND DECREED that Cortes Campers, LLC DBA Cortes Campers be and is hereby assessed a fine in the amount of FOURTEEN THOUSAND ONE HUNDRED (\$14,100.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Cortes Campers, LLC DBA Cortes Campers also be and is hereby assessed costs pursuant to La. R.S. 32:1260(C) in the amount of TWO THOUSAND TWO HUNDRED SIXTY-SEVEN DOLLARS AND FIFTY-SIX CENTS (\$2,267.56) to be paid to the Commission.

Judgment read and rendered on the 18TH day of November, 2024.

The Executive Director Casey presented to the Commission Members a copy of the 2023 -2024 Fiscal Audit. Executive Director Casey addressed the Commission with an overview of the highlights of the audit report which had been prepared by Griffin & Furman, LLC, an independent accounting firm, contracted through the Louisiana Legislative Auditor. Executive Director Casey concluded her presentation by stating there had been no findings or deficiencies detected for the commission in the report.

At 10:48 a.m. the executive session ended and the Commission meeting resumed.


