FINDINGS OF FACT, CONCLUSIONS OF LAW, AND JUDGMENT

On May 17, 2021, the Louisiana Motor Vehicle Commission (the "**Commission**") held a hearing on the Petition for Declaratory Ruling filed by Ray Brandt Infiniti of Metairie, L.L.C. d/b/a Porsche of New Orleans ("**Porsche N.O.**") in response to the above-captioned Complaint filed by Adam Schwartz ("**Mr. Schwartz**") against Porsche N.O.

Considering the pleadings, the testimony adduced at trial, the receipt of documentary evidence into the record, the applicable law, and the arguments of Mr. Schwartz and counsel for Porsche N.O., and for reasons orally assigned, the Commission makes the following findings of fact and conclusions of law, and enters the following judgment:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. The cost to repair the physical damage complained of by Mr. Schwartz in the above-captioned matter would have been substantially less than 6 % of the MSRP of the Porsche 911 Carrera vehicle he bought from Porsche N.O.
- 2. Porsche N.O. disclosed the discovery of a small chip in the paint under the front bumper.

CONCLUSION OF LAW

La. R.S. 32:1264, related to the duty to disclose physical damage in excess of 6% of MSRP, is inapplicable to the allegations made against Porsche N.O. filed by Adam Schwartz.

JUDGMENT

IT IS ORDERED, ADJUDGED, AND DECREED that the above-captioned Complaint filed by Adam Schwartz against Ray Brandt Infiniti d/b/a Porsche of New Orleans is hereby dismissed, with prejudice, at Adam Schwartz's cost.
