Being the first Commission meeting in the new building, Chairman Krake commended and thanked the Executive Director, Counselor Reggie and staff for their persistent effort, endurance and hard work so that the LMVC could finally be reside in a more suitable office space. The Commission echoed the Chairman's sentiments.

Chairman Krake called to order Hearing #2020-042, 2nd Chance Auto, LLC for the denial of a motor vehicle lessor and motor vehicle lessor used facility applications. Representing 2nd Chance Auto, LLC was: Avery Goins, Owner. A court reporter was brought into record the transcript of the hearing, which will be made a permanent part of the Commission's files. The following Judgment was rendered.

JUDGMENT:

This cause came to be heard on Monday, October 26, 2020 before the Louisiana Motor Vehicle Commission (the "Commission").

APPEARANCE: Avery Goins, 2nd Chance Auto, LLC

Gregory Reggie, Esq., Representing the Louisiana Motor Vehicle Commission;

And after hearing the testimony adduced at trial, the receipt of the documentary evidence into the record, and for reasons orally assigned, the Commission makes the following finding of fact and conclusions of law:

FINDING OF FACTS:

- Avery Goins, on behalf of/and 2nd Chance Auto, LLC ("Goins") applied for a Motor Vehicle Lessor license and a Motor Vehicle Used Facility license to the Louisiana Motor Vehicle Commission ("LMVC") in which application Goins stated he did not have any type of occupational license subject to denial or disciplinary action, when in truth and in fact the Louisiana Used Motor Vehicle Commission ("LUMVC") found that Goins violated one (1) count of La. R.S. 32:792(B)(3); seven (7) counts of La. R.S. 32:792(B)(9); and one (1) count of La. R.S. 32:792(B)(9) in LUMVC Case No. 2015-572 for which the LUMVC ordered Goins to pay fines and costs in the amount of \$4,200.00 within thirty (30) days of December 23, 2015 and DENIED issuance or reinstatement of a license to Avery Goins.
- In LUMVC Case No. 2015-572, the LUMVC assessed \$4,200.00 in costs and fines against Goins on December 23, 2015, which amount remains unpaid, and the LUMVC found and ordered Goins to be ineligible for licensing.

CONCLUSION OF LAW:

Based upon this finding of fact by the Commission, the decision made by the LMVC staff to deny Avery Goins and 2nd Chance Auto, LLC a Motor Vehicle Lessor license and a Motor Vehicle Used Facility license was proper and in accordance with the following law administered by the Louisiana Motor Vehicle Commission:

La. R.S. 32:1258(A) authorizes the LMVC to deny an application for a license:

- On satisfactory proof of unfitness of the applicant or the licensee, as the case may be, under the standards established and set out in Chapter 6 of Title 32;
- For any material misstatement made by an applicant in any application of license under the provisions of Chapter 6 of Title 32;
- For any violation of any law relating to the sale, lease, rental distribution, or financing of vehicles; and/or (6)
- The public interest is not served by the issuance of the license sought.

Considering the forgoing and pursuant to the authority vested in the Commission as set forth in La. R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED, and DECREED that the LMVC staff denial of a Motor Vehicle Lessor license and a Motor Vehicle Used

A brief discussion ensued					

The Executive Director reported to the Commission Members a Zoom video conference had been held at the request of LADA on September 28, 2020 regarding LADA's proposal to undertake a review and make changes to the advertising rules among other items. The Executive Director stated the attendees were Chairman Krake; Will Green, President of LADA; Claude Reynaud, Counsel for LADA; Commission Counselor, Gregory Reggie, Ingya Cattle, Assistant Executive Director; Tim Knotts, Assistant; and the Executive Director. At the conclusion of the meeting, a committee made up persons from each segment of the industry LMVC regulates, was suggested to oversees the advertising rules change. The Chairman stated LADA, in a separate meeting, had asked Otis Favre, Lakeshore Chrysler Dodge Jeep, Inc.; Tommy Harvey, Harvey Motors; Brett Oubre, Winnsboro Chrysler Dodge Jeep RAM; and Laird Doran, Gulf State Toyota and they had agreed to serve on the committee. Chairman Krake stated he had asked Commissioner Maurice Guidry, as well as, Commission staff, Mike Laviolette, Scott Landreneau, Neil Rogers, the Executive Director and Commission Counsel Reggie.

As a follow up to the Commission's decision at its March 12, 2018 and March 9, 2020 meetings regarding the civil penalty for unlicensed salesman, the Executive Director reported to the Commission Members and requested a clarification on Commissioner Lane's motion on March 9, 2020 meeting wherein "that a policy be adopted that if a dealer violate the same law for unlicensed salesman within one year of previous offence, a civil penalty for unlicensed salesman be imposed at a rate of five dollars per day for each day the salesman is not licensed, and ten dollars for the third offence and that in addition to that civil penalty a late filing fee be imposed in the amount of fifty percent of the regular license fee". At this time a lengthy discussion ensued. Commission Lane made a motion to clarify the previous motion by stating if a dealer violate the same law for unlicensed salesman within one year from last formally cited date, a civil penalty for unlicensed salesman be imposed at a rate of five dollars per day for each day the salesman is not licensed, and ten dollars for the third offence and that in addition to that civil penalty a late filling fee be imposed in the amount of fifty percent of the regular license fee. Commissioner Stephen Guidry seconded this motion and it was unanimously approved.

The Executive Director presented the Commission with a copy of the following legislative bill, though, it may not affect LRS 32:1251 et seq.
