Chairman Krake welcomed the newest member of the Commission, Raney Redmond. The Executive Director reported Commissioner Redmond had been appointed by the Governor on January 13, 2020, to replace of Bubba Perrilloux. The Executive Director stated Commissioner Redmond will represents Commission District 8 and is primarily engaged in the business of representing marine products sales.

At this time, Counselor LaPeyronnie reported to the Commission Members regarding the on-going litigations of the following:

- Wholesale Auto Group, Inc. (24<sup>th</sup> JDC, Jefferson Parish and 19<sup>th</sup> JDC, East Baton Rouge Parish)
- Elio Motors, Inc. (Louisiana Supreme Court)
- Skyrunner, LLC (United States District Court, Western District of Louisiana, Shreveport Division)

A brief discussion ensued.

The Executive Director updated the Commission Members regarding the progression of the renovation project of the Kingman Street building.

\*\*\*\*\*

The Executive Director reported to the Commission Members regarding a potential used motor vehicle facility that is owned by and under the same corporate name as a new motor vehicle dealer. Two potential concerns exist. How should the Commission license the used car facility when 1. the used facility's location is outside of the new motor vehicle dealer's area of responsibility; and, 2. the used facility's license is issued within the new motor vehicle's area of responsibility, but later the manufacturer changes the area of responsibility of the new motor vehicle dealer thereby leaving the used car location outside the new area of responsibility? After a lengthy discussion, Chairman Krake tabled the issue for further study.

\*\*\*\*\*

As a follow up to the Commission's decision at its March 12, 2018 meeting wherein "*Commissioner LeBlanc made a motion that a policy be adopted, that absent extenuating circumstances, if a Salesman's license is not obtained for a period of 15 days after employment commences, a civil penalty for that unlicensed salesman be imposed at a rate of two dollars per day for each day the salesman is not licensed, and that in addition to that civil penalty a late filing fee be imposed in the amount of fifty percent of the regular license fee. Commissioner Lane seconded this motion. The motion carried with a majority vote with Commissioner Westbrook casting a nay vote.*" The Executive Director advised the Commission Members that after two years of enforcing the above-mentioned policy, there are many second and even third offenders for unlicensed salesman, and she requested direction from the Commission

Members. At this time a lengthy discussion ensued. Commissioner Lane made a motion that a policy be adopted that if a dealer violate the same law for unlicensed salesman within one year of previous offence, a civil penalty for unlicensed salesman be imposed at a rate of five dollars per day for each day the salesman is not licensed, and ten dollars for the third offence and that in addition to that civil penalty a late filing fee be imposed in the amount of fifty percent of the regular license fee. Commissioner Marcotte seconded this motion and it was unanimously approved.

The Executive Director advised the Commission Members the following Consent Judgment had been recommended by Acting Chairman Krake and accepted by the representatives of Tiger Canopy Rentals, LLC, if accepted and ratified by the Commission. Commissioner Marcotte made a motion to accept and ratify the Consent Judgment in this matter. Commissioner Stephen Guidry seconded this motion and it was unanimously approved.
