The Executive Director reported to the Commission Members there has been a request from a TV Station to video record a formal hearing procedure. Therefore, the Executive Director requested the Commission Members to review and adopt standards for the use of lighting, recording or broadcasting equipment to insure proper decorum at a Commission public meeting pursuant to LSA-R.S. 42:23(B). At the conclusion of the review and discussion, Commissioner Scoggin made a motion to adopt the following standards. Commissioner Corley seconded this motion and it was unanimously approved.

**STANDARDS FOR THE USE OF LIGHTING, RECORDING, OR BROAD CASTING EQUIPMENT
LSA-R.S. 42:23**

1. Time to set up is no earlier than 1 hour 15 minutes before scheduled beginning of meeting and no later than 45 minutes before scheduled beginning of meeting.
2. There shall be no lighting other than the normal room lighting.
3. Equipment and personnel recording the meeting shall be confined to a space at the rear of the room, and shall not interfere with the hearing and viewing of others in attendance at the meeting.
4. Recording equipment shall not be removed from the hearing room until the Commissioners suspend the meeting to allow removal of same.

“As the exclusive distributor of new Toyota vehicles for the state of Louisiana, Gulf States Toyota is requesting approval to display forty (40) Toyota vehicles at the following event:

New Orleans, Louisiana 70130-1799

March 24, 2017 - March 26, 2017"

After a brief discussion, Commissioner Maurice Guidry made a motion to approve Gulf States Toyota, Inc.'s request as presented, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request correspondence of January 13, 2017, remaining constant. Commissioner Stephen Guidry seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members e-mails from Madeline Gigli, Event Production Manager of Experience Six, dated March 6, 2017 and March 8, 2017, wherein Ms. Gigli requested an approval from the Commission for Chrysler vehicles display and Ride and Drive at the Louisiana Sportsman Show:

On March 6, 2017:

“I work for a marketing company hired by FCA (Fiat, Chrysler, Dodge, Jeep & Ram) and we will be activation a small test drive at the Louisiana Sportsman Show taking place Gonzales, LA taking place March 16-March 19th. We will have a 30 x 90 display area with static vehicles and 3 Promotional Staff getting people to register for a sweepstakes. We will also have at least 3 RAM Trucks that we will be doing test drives with consumers on the surrounding streets.

On March 8, 2017:

“We will be having 2 RAM Trucks in our static display and 3 RAM's that will be part of the test drive. All the vehicles be coming from - Ralph Sellers Dealership. Please let me know if there is anything else that I can provide for you.”

After a brief discussion, Commissioner Maurice Guidry made a motion to approve FCA US LLC's request as presented, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request e-mails of March 6, 2017 and March 8, 2017, remaining constant. Commissioner Fontenot seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members an e-mail from Gregory Watson, Vice-President/Account Director Brand Content & Alliances of UniWorld Group, Inc., dated March 7, 2017, wherein Mr. Watson requested an approval from the Commission to display Ford vehicles and a Ride and Drive at 2017 Essence Festival:

“Thank you for facilitating the LMVC approval for Ford Motor Company to display vehicles at the ESSENCE Festival last year. As a returning sponsor, we are again seeking the Commission's approval of our display vehicles. Consistent with previous years, following are the details:

Sponsorship: Ford Motor Company is returning to 2017 Essence Festival as the exclusive automotive sponsor. Sponsorship includes rights to have static vehicle displays and to conduct a consumer Ride & Drive program.

Vendors: Both the Booth Display and Ride & Drive will be managed by a 3rd Party Event Management Company hired by UniWorld Group (an agent of Ford Motor Company.)

As in previous years, no Ford dealers will be engaged to have consumer interaction at the Festival, nor will dealer material or product brochures be distributed without the commission's approval."

After a brief discussion, Commissioner Maurice Guidry made a motion to approve Ford Motor Company's request as presented, conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request correspondence of March 7, 2017, remaining constant. Commissioner Fontenot seconded this motion and it was unanimously approved.

At this time Counselor LaPeyronnie reported to the Commission Members regarding the Kelley Blue Book Co., Inc. DBA KBB.com versus the Louisiana Motor Vehicle Commission, No. 2017-C-0032, in the Supreme Court of the State of Louisiana. Counselor LaPeyronnie reported that on February 10, 2017, the Supreme Court of the State of Louisiana denied Kelly Blue Book Co., Inc.'s Writ of Certiorari and/or Review, Parish of Jefferson, 24th Judicial District Court Div. K, No. 740-827; to the Court of Appeal, Fifth Circuit, No. 16-CA-281.

Based upon the legal work load, it would appear the limits of Counselor LaPeyronnie's contract could be exceeded, therefore, the Executive Director requested the following amendment be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed the maximum amount of \$310,000.00 for the period commencing January 12, 2016 and ending on January 11, 2018." After a brief discussion, Commissioner Westbrook made a motion to approve the amendment to Counselor LaPeyronnie's current contract. Commissioner Stephen Guidry seconded this motion and it was unanimously approved.

In attendance representing Mervin L. Stancil was himself and Richard Mary, Esq.; and representing the Commission were: Chairman Raymond J. Brandt; Mike Laviolette and Scott Landreneau, Commission Investigator Supervisors; Ingya Cattle, Assistant Executive Director; and the Executive Director. The Executive Director advised the Commission Members the following Consent Judgment had been recommended by Chairman Brandt and accepted by the representatives of Mervin L. Stancil, if accepted and ratified by the Commission. Commissioner Maurice Guidry made a motion to accept and ratify the Consent Judgment in this matter. - B.** That Respondent waives requirement that the Commission's judgment recites statement of a finding of fact(s) and conclusion(s) of law, and, to the extent that allegations have been made or contemplated by the Commission or its staff, it is acknowledged and agreed that Respondent has not, and is not, admitting or acknowledging any fact or act alleged or any violation of law that had been alleged, the Respondent agreeing that he has elected to not to contest the violations alleged or the potential violations alleged against Respondent, and the Commission agreeing that all pending allegations, investigations, and charges, and all matters, regarding violations or alleged violations of the statutes or rules of the Commission by Respondent, whether alleged or not, or whether the subject of any formal notice or not, are hereby resolved without contest;
- C.** That Respondent waives all right(s) to seek judicial review or otherwise to challenge or contest the validity of the judgment entered pursuant to this agreement;

- B. The requirement that the Commission's judgment recites statement of a findings of fact and conclusions of law; and
- C. All rights to seek judicial review or otherwise to challenge or contest the validity of the judgment entered pursuant to this agreement.

IT IS HEREBY FURTHER AGREED the Notice of Hearing may be used in construing the terms of the order. No agreement, understanding, representation or interpretation not contained in the order or the agreement may be used to vary or contradict the terms of the order.

IT IS ORDERED, ADJUDGED, AND DECREED that Morbark, LLC in complete satisfaction of all above-referenced violations, pay a fine to the Louisiana Motor Vehicle Commission in the amount of TEN THOUSAND (\$10,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that FIVE THOUSAND (\$5,000.00) DOLLARS of this fine be suspended conditioned upon Morbark, LLC being placed on ONE (1) YEAR probation beginning the date this Consent Judgment is rendered and signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Morbark, LLC pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of FOUR HUNDRED (\$400.00) DOLLARS.




