The Chairman called to order Hearing #2014-016, Bryan Chevrolet, Inc. and Hearing #2014-017, Bryan Imports, Inc. DBA Bryan Subaru for alleged violations of Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 13. New Motor Vehicle Auto Shows; Offsite Displays. §1307.A. and B. Static Offsite Displays. In attendance representing Bryan Chevrolet, Inc. and Bryan Imports, Inc. DBA Bryan Subaru was Jay Bryan, owner and dealer-operator. A court reporter was brought in to record the transcript of these hearings, which will be made a permanent part of the Commission's files.

JUDGMENT

This cause came to be heard on Monday, July 25, 2014.

And after hearing the testimony adduced at trial, stipulations made part of the record, the receipt of documentary evidence into the record, and for reasons orally assigned, the Commissioners of the Louisiana Motor Vehicle Commission ("the Commission") make the following finding of fact and conclusion of law:

Finding of Fact: Bryan Chevrolet, Inc. and Bryan Imports, Inc. displayed new motor vehicles off the site of their respective dealership premises and at the Louisiana Superdome, World of Wheels Auto Show without seeking and obtaining prior approval from the Louisiana Motor Vehicle Commission.

Conclusion of Law: Bryan Chevrolet, Inc.'s and Bryan Imports, Inc.'s display of new motor vehicles off the site of their respective dealership premises and at the Louisiana Superdome, World of Wheels Auto Show without seeking and obtaining prior approval from the Louisiana Motor Vehicle Commission constitutes a violation of the laws, rules and regulations of the Louisiana Motor Vehicle Commission, specifically Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 13. New Motor Vehicle Auto Shows; Offsite Displays §1307. Static Offsite Displays.

Considering the forgoing and pursuant to the authority vested in the Louisiana Motor Vehicle Commission set forth in LSA-R.S. 32:1251, et seq.:

IT IS ORDERED, ADJUDGED AND DECREED that Bryan Chevrolet, Inc. be and is hereby assessed a fine in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that TWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500.00) DOLLARS of the fine against Bryan Chevrolet, Inc. be suspended.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Bryan Imports, Inc. be and is hereby assessed a fine in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that TWO THOUSAND FIVE HUNDRED AND NO/100 (\$2,500.00) DOLLARS of the fine against Bryan Imports, Inc. be suspended.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Bryan Chevrolet, Inc. and Bryan Imports, Inc., jointly and in solido, pay the cost of the full board hearing to the Commission in the amount of Two Thousand Three Hundred Forty Dollars and Fifty One Cents (\$2,340.51).

With regard to old business, the Executive Director reported to the Commission Members, pursuant to the direction of the Commission at the last meeting, the staff had e-mailed the Bulletin to new motor vehicle manufacturers and dealers regarding the supplier's pricing advertising.

TO: All New Motor Vehicle Manufacturers and Dealers
FROM: L. A. House, Executive Director
RE: Advertising of "Supplier Pricing" and "Supplier Prices"

The staff of the Louisiana Motor Vehicle Commission has noticed a proliferation of the use of the term "supplier pricing" and/or "supplier prices" in the advertising for sale of new motor vehicles to the retail consumer.

Question Presented:

Can a new motor vehicle manufacturer or a new motor vehicle dealer advertise that the retail consumer can obtain "supplier pricing" and/or "supplier prices" in the purchase of a new motor vehicle.

Answer:

The answer is **NO!**

Why?

Rule 757 of the advertising rules and regulations of the Louisiana Motor Vehicle Commission have provided since January 2008, that terms such as "fleet prices," "fleet sales," "suppliers prices," or other terms implying that retail individual customers will be afforded the same price and/or discount as multi-purchase commercial businesses shall not be used in advertising.

As such, a manufacturer or dealer advertising "supplier pricing," "supplier prices," or words of similar import in the offering for sale of new motor vehicles to retail individual consumer is in violation of the laws, rules and regulations of the Louisiana Motor Vehicle Commission and is subject to enforcement action by the Louisiana Motor Vehicle Commission.

The Executive Director reported representatives of the Chevrolet Local Marketing Association ("LMA") requested attendance at today's meeting to address the supplier's pricing issue. At this time, the Chairman opened the floor for Claude Reynaud, Attorney of LADA to address "LMA"'s concern regarding this issue. Mr. Reynaud stated that the supplier's pricing is a General Motors' established price that is passed onto its customers during this campaign. Mr Reynaud continued by stating supplier's pricing is not a dealer pricing. Mr. Reynaud requested on behalf of the "LMA" that the Commission to withdraw the bulletin. After much discussion and review of a General Motors pricing sheet that clearly listed a definite and specific supplier price which must be utilized, according the General Motors rules of the program, as the cash sales price of the vehicle to retail individual customers in the calculation of the final sales price, Commissioner Hocesvar made a motion to allow General Motors and its dealers to utilize supplier pricing in the current General Motors campaign, however any further amendments to Bullegin B-2014-001 would have to be decided on a case by case basis. Commissioner Hargroder seconded this motion and it was unanimously approved. The Commission instructed the staff to send out a new bulletin to announce this decision.

The Executive Director presented to the Commission Members an e-mail correspondence from Danielle Cooley, Promotions Manager of Jack Morton Worldwide, on behalf of Chevrolet to Neil Rogers, Commission Investigator on June 4, 2014, requesting approval for new motor vehicle off-site display:

"Chevrolet requests permission to display Chevrolet vehicles and conduct a ride and drive at the Southern Sportsman's Festival & Expo at the Alario Center in Westwego, Louisiana on August 15-17. Chevrolet would like to participate to support the local community in Louisiana.

Vehicle Display Activation Special Request

The ride and drive will take place onsite at the Alario Center. It will stay on the property in the parking lot and field in the back. As a plan B if there is rain we will drive down Segnette Boulevard and make a U-turn to come back.

Chevrolet requests the opportunity to staff the vehicle display and ride and drive with an event manager, promotion specialists and product specialists who can provide vehicle feature information to consumers. These individuals are employed by a 3rd party vendor and are not employed by any dealership nor are they able to discuss dealer pricing or sell vehicles onsite. This staff would act as a brand ambassador giving consumers Chevrolet vehicle information.

Chevrolet also request the opportunity to conduct lead generation through this staff by offering attendees of the show a premium item (i.e., hat, shirt) in exchange for him/her to fill out a card with their contact information. This contact information will be submitted through Chevrolet's approved system which follows privacy acts and laws.

We appreciate your consideration of our request. Please do not hesitate to contact us with any questions."

After a brief discussion, Commissioner Hocevar made a motion to approve Jack Morton Worldwide's request to display eight new Chevrolet vehicles, ride and drive, and staff product specialists at the Southern Sportsman's Festival & Expo at the Alario Center in Westwego, Louisiana on August 15 to 17, 2014. Commissioner Hargroder seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members an e-mail correspondence from Henry Li, Regional Market Associate of Jack Morton Worldwide, to Neil Rogers, Commission Investigator on May 28, 2014, requesting approval for new motor vehicle off-site display:

"The Super Chevy Dealers of Baton Rouge are partnering with the Cabela's in Gonzales to put on a Ride & Drive Program. The dealers are going to conduct a Ride & Drive and have several vehicle displays at Cabela's in Gonzales.

The Super Chevy Dealers of Baton Rouge would like to request permission to display 5 Chevy vehicles and use 5 Chevy vehicles to conduct a Ride & Drive program at Cabela's in Gonzales. This event will be fully executed by a third party outside vendor, STI. Every participant who partakes in a test drive will receive a \$10 gift card to Cabela's. People who participate in our static display Measure-up Challenge will receive a multi tool.

The vehicles will be provide by the Super Chevy Dealers and each dealership that is going outside their jurisdiction has received approval from the dealership within the area that the event is taking place at. The dealership that provided approval is Supreme Chevrolet.

The event dates are August 15-17, 2014 during store hours.

We appreciate your consideration of our request. Please contact me with any questions you might have."

After a brief discussion, Commissioner Corley made a motion to deny the distribution of Cabela's gift cards to attendees and to approve Jack Morton Worldwide's request for five new Chevrolet vehicles for display, five new Chevrolet vehicles for ride and drive, the presence of staff product specialists and the distribution of multi tools at Cabela's in Gonzales, Louisiana on August 15 to 17, 2014. Commissioner Bent seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members for their review the completed Fiscal Audit Compliance Questionnaire for the fiscal year of 2013-2014. After a brief discussion, Commissioner Duhon made a motion to approve Fiscal Audit Compliance Questionnaire. Commissioner Hocevar seconded this motion and it was unanimously approved.

After a brief discussion, it was decided that the next regularly scheduled commission meeting would be held on November 17, 2014 instead of November 10, 2014, due to Veterans Day, which is a state holiday.

With regard to old business, a discussion ensued regarding the Governor's veto of SB No. 318. Commissioner Duhon made a motion to enforce the law by sending a cease and desist order to all manufacturers to stop paying warranty claims to unlicensed vendors. Commissioner Timmons seconded this motion and it was unanimously approved.

The Executive Director advised the Commission Members a pre-hearing had been on May 19, 2014, pursuant to LSA-R.S. 49:961C, regarding Bertucci #2014-006, Tarver Automotive Group, L.L.C. DBA Tarver Ford, 930 Beglis Parkway, Sulphur, Louisiana 70663, for alleged violations of LSA-R.S. 6:969.18.B. and F.; LSA-R.S. 13:844.A.(1); LSA-R.S. 32:412.1.A.(3)(a); LSA-R.S. 32:728.(1), (5), & (6); LSA-R.S. 32:1251.; LSA-R.S. 47:304.D.; LSA-R.S. 47:462.A.(1), B.(3)(a); and LSA-R.S. 47:463.A.(1)(a) & (2). In attendance representing Tarver Automotive Group, L.L.C. DBA Tarver Ford was Philip Tarver, Owner. Representing the Commission were: Chairman Raymond J. Brandt; Counselor Gregory Reggie; Wayne Lee, Commission Investigator Supervisor; Amy Lawson, Scott

Landreneau, and Neil Rogers, Commission Investigators; Ingya Cattle, Assistant Executive Director; and the Executive Director. The Executive Director advised the Commission Members the following Consent Judgment had been recommended by the Acting Chairman and accepted by the representative of Tarver Automotive Group, L.L.C. DBA Tarver Ford, if accepted and ratified by the Commission. A question was posed regarding the overcharge to be refunded to consumer to which the Executive Director responded the total amount to be refunded was \$156,595.77. After further discussion, Commissioner Hargroder made a motion to accept and ratify the Consent Judgment in this matter. Commissioner LeBlanc seconded this motion and it was unanimously approved.

CONSENT JUDGMENT

After considering the entire record in this matter and the interest of the parties in amicably resolving it, the parties have consented to a judgment in favor of the Louisiana Motor Vehicle Commission based upon alleged violations by Tarver Automotive Group, L.L.C. DBA Tarver Ford of LSA-R.S. 6:969.18.B. and F.; LSA-R.S. 13:844.A.(1); LSA-R.S. 32:412.1.A.(3)(a); LSA-R.S. 32:728.(1), (5), & (6); LSA-R.S. 32:1251.; LSA-R.S. 47:304.D.; LSA-R.S. 47:462.A.(1), B.(3)(a); and LSA-R.S. 47:463.A.(1)(a) & (2). Therefore, based on the parties' mutual consent;

IT IS HEREBY AGREED by and between Tarver Automotive Group, L.L.C. DBA Tarver Ford and the Louisiana Motor Vehicle Commission that respondent waives:

- A. Any further procedural rights or remedies afforded under the law;
- B. The requirement that the Commission's judgment recites statement of a findings of fact and conclusions of law; and
- C. All rights to seek judicial review or otherwise to challenge or contest the validity of the judgment entered pursuant to this agreement

IT IS HEREBY FURTHER AGREED the Notice of Hearing may be used in construing the terms of the order. No agreement, understanding, representation or interpretation not contained in the order or the agreement may be used to vary or contradict the terms of the order.

IT IS ORDERED, ADJUDGED, AND DECREED that Tarver Automotive Group, L.L.C. DBA Tarver Ford in complete satisfaction of all above-referenced violations, pay a fine to the Louisiana Motor Vehicle Commission in the amount of TWELVE THOUSAND AND FIVE HUNDRED (\$12,500.00) DOLLARS.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that TWELVE THOUSAND AND FIVE HUNDRED (\$12,500.00) DOLLARS of the fine be suspended conditioned upon Tarver Automotive Group, L.L.C. DBA Tarver Ford refund the overcharged fees, described in the audit report, to its customers within thirty days, beginning the date this Consent Judgment is rendered and signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission. In the event of a violation during the thirty-day period, the suspended portion of the fine shall become due and payable in full.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Tarver Automotive Group, L.L.C. DBA Tarver Ford pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of THREE HUNDRED (\$300.00) DOLLARS.
